Artificially Propagated certificate - RM 50.00 / certificate

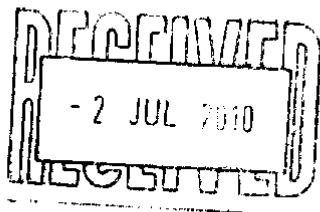
